# Determination of the tuition fee amount for study in a foreign language at the Faculty of Economics and Management in the Academic Year 2025/2026

## Article 1

#### **Introductory Provisions**

- (1) The Dean's Decree is valid for the Faculty of Economics and Management (hereinafter the "faculty") of the Czech University of Life Sciences Prague (hereinafter "CZU"), and it determines the fee amount for study in a foreign language in the academic year 2025/2026.
- (2) The Decree is prepared in particular in accordance with Act No. 111/1998 Coll., on Higher Education Institutions, as amended (hereinafter the "Act"), and in accordance with Article 25 of the Statute of the Czech University of Life Sciences Prague (hereinafter the "Statute").

# Article 2 Determination of the tuition fee amount for study in a foreign language

(1) The amount of the annual fee for studying in a study programme <u>for EU-students</u> registered for study as of the 2025/2026 academic year in a foreign language pursuant to Section 58, paragraph 4 of the Act (hereinafter the "fee for study in a foreign language") is as follows:

(2) The amount of the annual fee for studying in a study programme <u>for non-EU students</u> registered for study as of the 2025/2026 academic year in a foreign language pursuant to Section 58, paragraph 4 of the Act (hereinafter the "fee for study in a foreign language") is as follows:

- (3) The decision on assessment of the fee for study in a foreign language pursuant to paragraph 1 of this Article shall be issued by the Dean or his authorized Vice Dean of the faculty, and the fee shall be due before the date of registration for study, or before the date of registration for study in a higher year.
- (4) The Dean or his authorized Vice Dean may decrease the fee amount to the level of the fee amount that was valid in the academic year in which the student registered for the study. In accordance with Section 68, paragraph 3 of the Act, the issuing of a decision pursuant to this paragraph is the first act in the proceedings.
- (5) Other details regarding the proceedings on assessment of the fee pursuant to for study in a foreign language, as well as payment of the fee, shall be determined by legal regulations, Article 25 of the CZU Statute, and by an Internal Regulation of CZU for determining the fee associated with the study and the amount of the payments for administrative acts and services issued by the Rector.
- (6) In exceptional and justified cases (such as visa denial etc) it is possible to apply for refund of study fee in a foreign language. The decision on study fee refund is made by the Dean or his authorized Vice Dean of the faculty. A cancellation fee of 2 500 CZK is charged when the fee for study in a foreign language is refunded.

#### Article 3

#### **Closing Provisions**

- (1) The Decree was discussed by the CZU Rector's Advisory Board on 3.6.2024.
- (2) The Decree shall become valid and effective on the date it is published in the public part of the CZU website.
